1 HEARING EXAMINER BRANCARD: With that, proceed  
2 with case 21974, Titus Oil & Gas.

3 MR. McINTYRE: Yes, Mr. Hearing Examiner, John  
4 McIntyre with Montgomery and Andrews appearing on behalf of  
5 Titus Oil & Gas.

6 HEARING EXAMINER BRANCARD: Are there any other  
7 interested parties in this matter?

9 HEARING EXAMINER BRANCARD: Hearing none, you may  
10 proceed, Mr. McIntyre.

11 MR. McINTYRE: So this case has to do with the  
12 Lonesome Dove Fed Com 204H. Again, about a year ago Titus  
13 had filed several applications that were approved by the  
14 Division for compulsory pooling for the same Lonesome Dove  
15 well family and is adding an additional horizontal spacing  
16 unit to that well family.

17 This spacing unit comprised -- comprised of the  
18 E/2 NE/4 of Section 17 and the E/2 E/2 of Section 8,  
19 Township 26 South, Range 35 East in Lea County developing  
20 the Bone Spring formation.

21 Again, this well will share the same well pad as  
22 Cattleman well that I just previously presented in the front  
23 of the Division. The exhibit package is organized the same  
24 way, checklist, application, landman affidavit Exhibit A  
25 with the corresponding landman exhibits, geologist affidavit

1 Exhibit B with the corresponding geologist exhibits, and  
2 affidavit of notice in Exhibit C.

3 Also, as I had just mentioned, we did receive all  
4 the green cards back for this case. Notice was properly  
5 given as reflected in Exhibit A-7 and Exhibit C.

6 And with that, we request that the admission of  
7 the application, the affidavits and exhibits and ask that  
8 the Division take this case under advisement.

11 TECHNICAL EXAMINER McCLURE: I have no questions
