- 2 COMMISSION CHAIR SANDOVAL: On to Agenda Item
- 3 No. 4, which is Final Action in Case No. 21834.
- 4 This was the Application by the New Mexico
- 5 Oil Conservation Division and Wild Earth Guardians to
- 6 Amend Rules 19.15.29.6, 19.15.29.8, and 19.15.29.15 NMAC.
- 7 This was taken under consideration in a motions hearing on
- 8 June 4th. Then there was testimony and expert witnesses
- 9 put on by the parties and public comment put on on June
- 10 9th and 10th, followed immediately by deliberations of the
- 11 Commission, and the changes were voted on by the
- 12 commissioners at that meeting.
- 13 There has been a Final Order that was
- 14 circulated both with the parties as well as the
- 15 commissioners.
- 16 Commissioners, have you had an opportunity
- 17 to review that Final Order and do you have any comments or
- 18 changes to it?
- 19 COMMISSIONER BLOOM: Madam Chair, I did spend
- 20 time reviewing the Final Order in Case 21834, and I find
- 21 it meets all my needs. Thank you.
- 22 COMMISSIONER WARNELL: Madam Chair, Commissioner
- 23 Warnell. I also reviewed, read and studied Case 21834,
- 24 and have no further changes or comments.
- MR. MOANDER: Madam Chair, I would ask one

- 1 question of Commissioner Warnell.
- I understand that you wanted me to change
- 3 the signature block through you to be more accurate. How
- 4 would you like your name to be listed? I can make that
- 5 minor change with the approval of the Commission.
- 6 COMMISSIONER WARNELL. Well, I think probably
- 7 the best thing to do is just remove the P.E.
- 8 MR. MOANDER: Okay. I can make that happen.
- 9 I'll request from the Commission, after the
- 10 rest of this discussion is held, for some scrivener's
- 11 authority to make that change.
- 12 So we can address that at the end. But
- 13 thank you, Commissioner Warnell.
- 14 COMMISSION CHAIR SANDOVAL: Thank you. I have
- 15 also reviewed the Order, as well as the Rule changes that
- 16 were made, and they reflect the testimony and the record
- 17 from the hearing on June 4th and then June 9th and the
- 18 10th. And so the Order I think reflects what the intent
- 19 was of the Commission and what was stated at those
- 20 hearings.

- 6 Mr. Moander, would you please do a roll
- 7 call vote.
- 8 MR. MOANDER: Yes, Madam Chair.
- 9 Commissioner Warnell.
- 10 COMMISSIONER WARNELL: Yes, approved.
- 11 MR. MOANDER: Commissioner Bloom.
- 12 COMMISSIONER BLOOM: Approve.
- 13 COMMISSION CHAIR SANDOVAL: And Madam Chair.
- 14 COMMISSION CHAIR SANDOVAL: Approve.
