Yes. There are 3 problems:

1. The Yeso wells are subject to a plugging order, so Chica will need to enter an agreed compliance order.
2. The plugging order requires the transfer to be to an entity not affiliated with Yeso, and we have evidence that the owner of Chica is the daughter of the owner of Yeso.
3. My understanding is that the wells are already under a plugging contract, or on the plugging list, so Daniel would have to agree to stop the plugging.
