This is a hearing of the New Mexico Oil Conservation Commission, Energy, Minerals and 3 4 Natural Resources Department. We have a court reporter 5 today, so please speak clearly and slowly when necessary. With us as a technical examiner today is Kathleen 6 7 Murphy. I believe she has an announcement today. 8 Kathleen, I think you are muted. 9 TECHNICAL EXAMINER MURPHY: Good morning. I have 10 a couple announcements. The UIC team has a new team member, and this is Joseph Thompson who is, who is attending for the 11 12 first time, comes to us from New Mexico Tech with a 13 bachelor's degree in petroleum engineering. 14 And he has worked as a hydraulic fracturing 15 engineer for three years with Profrac Services. As a field engineer he gained knowledge in many aspects of field 16 17 operations including fluid testing and analysis, real time well monitoring and evaluation, and post job assessment and 18 19 reporting. He has worked stimulation projects in several 20 basins including the Permian, Eagleford and Marcellus, and 21 we welcome him. We have much interesting work, and we look 22 forward to his help in accomplishing goals of the UIC 23 24 program. 25 On another note for the examiner side, the UIC
