1 HEARING EXAMINER BRANCARD: With that, calling

- 2 Item Number 33, Case 22033, Kaiser-Francis.
- 3 MR. BRUCE: Mr. Examiner, Jim Bruce for the
- 4 applicant, and I just received an e-mail from Mr. Feldewert
- 5 saying that MRC Permian is no longer involved in this case.
- 6 HEARING EXAMINER BRANCARD: Well, okay.
- 7 MR. BRUCE: He asked me to inform you of that.
- 8 HEARING EXAMINER BRANCARD: Has he ducked out of
- 9 the hearing?
- 10 MR. BRUCE: I think so.
- 11 HEARING EXAMINER BRANCARD: Apparently so. I
- 12 believe he was on earlier. All right. Mr. Rankin, is that
- 13 okay with you?
- MR. RANKIN: Whatever is okay with Mr. Feldewert
- 15 is okay with me.
- 16 HEARING EXAMINER BRANCARD: All right. Are there
- 17 any other entries of appearance for case Number 22033?
- 18 (No audible response.)
- 19 HEARING EXAMINER BRANCARD: With that, Mr. Bruce,

- 14 HEARING EXAMINER BRANCARD: I want to take a step
- 15 backwards here and let's go back to Case 22033. Mr. Bruce,
- 16 are you there.
- 17 MR. BRUCE: Yes, I am. Thankfully Mr. Baca got
- 18 the transcripts done quickly on this, and I went back
- 19 because I was confused by this.
- 20 So what happened two weeks ago, Mr. Bruce, is you
- 21 had your exhibits filed and your prehearing statement filed
- 22 right before the hearing.
- MR. BRUCE: That's right, I forgot about that,
- 24 Mr. Examiner.
- 25 HEARING EXAMINER BRANCARD: And we decided to

- 1 actually continue the case because you just filed it, so you
- 2 never got your exhibits admitted into the record. So can we
- 3 go back into Case 22033 and start up this hearing again, if
- 4 you are ready to do so, Mr. Bruce?
- 5 MR. BRUCE: I am. Give me one second here so I
- 6 can pull up my copy of the exhibits. Okay, here we go.
- 7 Yes, Mr. Examiner, in this matter applicant seeks
- 8 to pool the E/2 NE of Section 25 and the E/2 E/2 of Section
- 9 24 in 23 South, 28 East for the Wright Federal 2H well.
- 10 Exhibit 1 is the application and proposed notice,
- 11 Exhibit 2 is the landman's affidavit which identifies the
- 12 usual -- contains the usual exhibits, shows who is being
- 13 pooled. And requesting overhead rates of, I think it's
- 14 8,000 per month for a drilling well, 800 for a producing
- 15 well and requesting the 200 percent penalty.
- 16 The geologist affidavit contains the structure
- 17 map, isopach and cross section showing that -- which is
- 18 Exhibit 3 -- shows the usual documents, and that the, the
- 19 formation being pooled, which is what they are targeting is
- 20 the Lower Brushy Canyon portion of the Delaware Formation is
- 21 continuous across the well unit in each quarter-quarter
- 22 section to contribute to production.
- 23 And then there's my affidavit of mailing, Exhibit
- 24 4, affidavit of publication, I believe notice is proper --
- 25 kind of a change for me. And then the pooling checklist is

- 1 Exhibit 6. And I think all the documents are there.
- 2 MRC Permian was involved because the -- MRC
- 3 Permian and Kaiser-Francis were kind of working together in
- 4 this area to decide who would be operating certain acreage,
- 5 and, in the end, Kaiser-Francis got this acreage, and so
- 6 that's why MRC Permian stepped out.
- 7 And so I think all is set to go, and I would ask
- 8 that Exhibits 1 through 6 be taken under advisement --
- 9 exhibits be admitted into evidence and the matter be taken
- 10 under advisement.
- 11 HEARING EXAMINER BRANCARD: Thank you. Ms.
- 12 Murphy, do you have any questions?
- 13 TECHNICAL EXAMINER MURPHY: I do not have any
- 14 questions. Thank you.
- 15 HEARING EXAMINER BRANCARD: Once again, are there
- 16 any other interested persons for Case 22033, application of
- 17 Kaiser-Francis?
- 18 (No audible response.)
- 19 HEARING EXAMINER BRANCARD: Hearing none, the
