RANKIN: Good morning, Mr. Examiner, may it 3 4 please the Division, Adam Rankin with the Santa Fe office of 5 Holland & Hart appearing on the behalf of the applicant in this case. 6 7 HEARING EXAMINER BRANCARD: Thank you. Are there any other interested persons for Case 22421? 8 9 (No audible response.) 10 HEARING EXAMINER BRANCARD: Hearing none, Mr. Rankin, update us where we are. 11 12 MR. RANKIN: Thank you very much, Mr. Examiner. 13 This is another situation where this case was continued due 14 to a late notice of publication in the newspaper. 15 Accordingly, we have continued the case to this date to permit the notice period to run. To my knowledge, 16 no parties have entered an appearance in the record nor have 17 they appeared today. 18 Since the last hearing, Mr. Examiner, we did file 19 two revised exhibits to make minor corrections to the 20 compulsory pooling checklist which is marked as Exhibit A, 21 and to file a revised or corrected C-102 for the proposed 22 initial well which is marked as revised Exhibit C-3. Both 23 24 of those revised exhibits have been filed of record with the 25 Division through the portal with a cover, cover notice

So those are now of record with the Division and 3 we ask that those be accepted into the record. 4 One other minor correction that we want to make, I think a statement was made on the record that the proposed 5 spacing unit is all fee land, I believe, but actually there 6 7 are -- there is a state lease -- rather, a federal lease within the spacing unit, so we want to make that clear as 8 9 well. 10 So with that, Mr. Examiner, if there are no other questions from the Division or examiners, we ask that this 11 12 case be taken under advisement. HEARING EXAMINER BRANCARD: Thank you. Your 13 14 exhibits are in the case file and they will be admitted. 15 (Exhibits admitted.) Am I coming in? 11 12 MR. FELDEWERT: I can hear you. 13 HEARING EXAMINER BRANCARD: Mr. Rankin, did we 14 lose you? I can see you, Mr. Rankin. 15 TECHNICAL EXAMINER LOWE: Now he is really gone. HEARING EXAMINER BRANCARD: Yeah, Mr. Rankin has 16 left the building. He may be coming into your office, Mr. 17 Feldewert. 18 MR. FELDEWERT: He's coming into my office. I'm 19 going to back up. Go ahead, Mr. Examiner. 20 21 HEARING EXAMINER BRANCARD: Mr. Rankin, I was thanking you because your notice did describe what the 22 23 changes were to the checklist, so that's helpful in regards to Mr. Lowe's question. 24 25 Are there any other interested persons then or
