Thank you. 7 Mr. Rose-Coss, any announcements for today? 8 TECHNICAL EXAMINER ROSE-COSS: None from the Division today. 9 10 HEARING EXAMINER BRANCARD: Thank you. The worksheet for today's agenda is listed on the website at the 11 12 New Mexico Oil Conservation Division. We started with 157 13 cases on the docket, we are down to 43 and some of those 14 shouldn't be on there, anyway, so see how this one goes. 15 (Docket heard.) (The following discussion was held following 16 completion of the docket.) 17 MR. SALMONEGA: Mr. Brancard, Mr. Brancard, I 18 would like to ask about the Case Numbers 21383, 84, 85, 86. 19 Cases Numbers 20840, 41, 42, 43, 44, 48, Marathon and 20 Matador. SALMONEGA: When were the dismissals filed? HEARING OFFICER BRANCARD: You can look that up 5 6 in the case file very easily. 7 MR. SALMONEGA: I just want to get on the record. When were the cases dismissed? When were the files --8 because you dismissed it, was a formal dismissal submitted? 9 10 HEARING OFFICER BRANCARD: It appears that there was a motion to dismiss filed by both parties on April 15, 11 12 and then an order was issued by the Division director on 13 April 19. 14 MR. SALMONEGA: Have there been any filings 15 submitted to, to apply for any wells on these -- off of these case numbers? 16 17 HEARING OFFICER BRANCARD: Mr. Salmonega, I would have no idea. You would have to --18 MR. SALMONEGA: The old numbers 20772, I 19 contested them and now the numbers have changed also, and 20 you know, 21383, 84, 85, 86, so they continue to change. 21 So I'm just making sure there has not been nothing submitted to 22 open them under different case numbers or different well 23 24 names. 25 HEARING OFFICER BRANCARD: The notice of this
