- 2 EXAMINER BRANCARD: All right. With that, I'm on
- 3 Item 43 on the agenda, Case Number 22075, Catena, if I
- 4 pronounced that correctly, Resources Operating.
- 5 MS. McLEAN: Good morning, Mr. Examiner. Jackie
- 6 McLean for Catena Resources Operating.
- 7 EXAMINER BRANCARD: Thank you. I have an entry
- 8 from COG Operating.
- 9 MS. RYAN: Yes. Beth Ryan appearing for COG
- 10 Operating.
- 11 EXAMINER BRANCARD: All right. So, Ms. McLean,
- 12 are you going to handle this case by itself? This is --
- 13 well, 22075, I think, are there anyone else interested in
- 14 that case? Hearing none, please proceed, Ms. McLean.
- 15 MS. McLEAN: Thank you. In Case Number 22075,
- 16 Catena seeks to pool all uncommitted interests in the Bone
- 17 Spring formation in a 320-acre standard horizontal spacing
- 18 unit comprised of the E/2 W/2 of Sections 8 and 17, of
- 19 Township 19 South, Range 35 East, in Lea County, New Mexico.
- 20 And this spacing unit will be dedicated to the Rambo E2W2
- 21 08-17 B1 1H well, which will be horizontally drilled from a
- 22 surface location in the NE/4 NW/4 of Unit C of Section 8, to
- 23 a bottom hole location in the SE/4 SW/4 Unit N of
- 24 Section 17.
- 25 And the exhibit packets submitted to the Division

- 1 contain Exhibit A, which is the land professional's
- 2 testimony and related exhibits, which include a plot of
- 3 tracts, ownership interest, pooled parties, a well proposal
- 4 letter, and a summary of communications. There's also
- 5 Exhibit B, which is a self-affirmed statement of geologist
- 6 Catherine Henry. Ms. Henry has not previously testified
- 7 before the OCD, so Exhibit B1 is a copy of her resume, and
- 8 as you can see from Exhibit B1, Ms. Henry is well qualified
- 9 to testify before the Division on geology matters as she
- 10 holds a Master's of Science in geology, and has experience
- in the petroleum industry focusing on well planning,
- 12 resource development, and resource evaluation for horizontal
- 13 drilling programs in the Delaware, Permian and Williston
- 14 basins, and I ask that the Division accept Ms. Henry as an
- 15 expert in geology and admit her testimony into evidence in
- 16 this case.
- 17 EXAMINER BRANCARD: Thank you. Any objections?
- 18 Hearing none, she is admitted as an expert.
- 19 MS. McLEAN: Thank you, Mr. Examiner. And then,
- 20 finally, Exhibit C is a notice affidavit from our office,
- 21 which sets out when the notice letter of this hearing and
- 22 application were sent to all parties to be pooled. And we
- 23 sent out two letters, one in July 2021, and one in February
- of 2022, and we also published in the Hobbs paper on
- 25 July 14th, 2021, and March 2nd, 2022, and a copy of the

- 1 affidavits of publication are Exhibit C3.
- 2 And with that, I ask that Exhibits A, B and C be
- 3 admitted into the record in Case Number 22075, and that Case
- 4 Number 22075 be taken under advisement.
- 5 EXAMINER BRANCARD: Thank you.
- 6 Ms. Ryan, any questions, comments?
- 7 MS. RYAN: No questions, thanks.
- 8 EXAMINER BRANCARD: Thank you.
- 9 Mr. McClure?
- 10 TECHNICAL EXAMINER McCLURE: Mr. Brancard, no
- 11 questions here either.
- 12 EXAMINER BRANCARD: Thank you. All right.
- 13 Ms. McLean, I'm looking at two exhibits of yours, one, A3,
- 14 lists the interest owners, okay, and there's only three
- 15 parties to be pooled; is that correct?
- MS. McLEAN: That's correct.
- 17 EXAMINER BRANCARD: When we get over to Exhibit C
- 18 and who you're giving notice to, there's now five parties
- 19 listed. Do you happen to know what the difference is?
- MS. McLEAN: Yes. Yes, the reason why we -- it's
- 21 the reason why we sent notice letters in February of this
- 22 year. As you can see, there were some that were sent in
- 23 July 2021, and then some that were sent in February 2022,
- 24 and COG was sent notice in July 2021, but the other two
- 25 parties, Featherstone and Deborah K. Premiera (phonetic),

1 who received the notice letter in February 2022, those are

- 2 the only three parties at this point that we are seeking to
- 3 pool. The other parties no longer need to be pooled in this
- 4 case.
- 5 EXAMINER BRANCARD: Okay. And so I'm -- I will
- 6 ask that -- I will assume that that applies to the last
- 7 entity there, South Fifth Energy.
- 8 MS. McLEAN: That's correct, Mr. Examiner.
- 9 EXAMINER BRANCARD: They are a committed party.
- 10 MS. McLEAN: Correct.
- 11 EXAMINER BRANCARD: Okay. It concerned me that
- 12 you were not able to contact them at first because they have
- 13 been a party in some of our proceedings, so they are
- 14 contactable, which I guess you did.
- MS. McLEAN: Yes, yes, we did.
- 16 EXAMINER BRANCARD: Thank you.
- 17 MS. McLEAN: And -- sorry. And if it was unclear,
- 18 we tried to put each entry separate so that we could show,
- 19 you know, who exactly was contacted and when.
- 20 EXAMINER BRANCARD: Thank you. I have no further
- 21 questions, then.
- 22 Are there any other interested persons, then, for
- 23 Case 22075? Hearing none, Case 22075 will be taken under
- 24 advisement.
- MS. McLEAN: Thank you, Mr. Examiner.
