NOTICE OF STIPULATED DISMISSAL

NOTICE IS HEREBY GIVEN that Colgate Operating, LLC (OGRID 371449), the applicant in this case and Division-approved operator under Order No. R-21575, hereby voluntarily dismisses Case No. 21629 and dismisses and terminates Division Order No. R-21575 (the “Order”) issued from said Case. The Order is subject to a stay issued by the Commission (Order No. R-21679-A) and is under de novo review by application from Cimarex Energy Company (“Cimarex”) in Commission Case No. 21744. Accordingly, the approved initial well has not been drilled, AFEs and elections have not been sent to working interest owners pursuant to the Order, and no share of well costs have been collected by Colgate. This dismissal is being made on the condition and understanding that Cimarex will dismiss its de novo application in Case No. 21744 and its competing compulsory pooling applications under Case Nos. 22018-22019 without prejudice to re-file its compulsory pooling applications with the Division. No party opposes dismissal of Case No. 21679 or its Order No. R-21575.
