Williams Production Company, LLC ("Williams") is making an application to designate a Project Area pursuant to Division Rules 19,15.16.7 and 19.15.16.14 in include all of the Mancos Participating Area within the Rosa Unit located in San Juan and Rio Arriba counties. McElvain currently owns uncommitted leasehold in the Mancos Participating Area that is governed by separate Joint Operating and Communitization Agreements. If the Project Area that Williams' is apphing for is approved, McElvain's leasehold could be drained without setback requirements or obligations to drill additional wells to prevent drainage.
