OCD Rule 1211.B requires parties who intend to present evidence at an adjudicatory hearing to file a pre-hearing statement no later than the Thursday before the hearing, and serve a copy on opposing counsel of record. If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing may be continued at the applicant's request. The following cases will be heard by an Examiner.

- 1. CASE 14613: Amended Application of COG Operating LLC for special rules, Eddy and Lea Counties, New Mexico.

 Applicant seeks an order establishing special rules and regulations for the Artesia Glorieta-Yeso, Bear Grass Draw Glorieta-Yeso, Cedar Lake Glorieta-Yeso, Empire Glorieta-Yeso, East Empire Glorieta-Yeso, Fren Glorieta-Yeso, East Fren Glorieta-Yeso, Grayburg Jackson Seven Rivers-Queen-Grayburg-San Andres-Glorieta-Yeso (Paddock), Grayburg Jackson Seven Rivers-Queen-Grayburg-San Andres (within the Dodd and Burch Keely Units), Grayburg Jackson Yeso, North Leamex Paddock, Loco Hills Glorieta-Yeso, and West Maljamar Yeso, and Cancellation of Overproduction, Lea and Eddy Counties, New Mexico, including a depth bracket allowable of 300 barrels of oil per day and no limiting gas-oil ratio. The pools are located approximately 12 miles east of Artesia, New Mexico and 17 miles West of Lovington, New Mexico.
- 2. CASE INDICATE Application of Burnett Oil Co., Inc. and Hudson Oil Company of Texas for consolidation and expansion of and adoption of special pool rules for certain Yeso Pools in Lea and Eddy Counties, New Mexico. Applicants seek an order establishing consolidation, expansion of, and adoption of special pool rules and regulations for the Cedar Lake Glorieta-Yeso Pool, Fren Glorieta-Yeso Pool, East Fren Glorieta-Yeso Pool, Loco Hills Glorieta-Yeso Pool, Maljamar Paddock North Pool, and West Maljamar Yeso Pool, Lea and Eddy Counties, New Mexico, including specifying a vertical interval to be defined as from the top of the Glorieta formation through the top of the Tubb member of the Yeso formation, a depth bracket allowable of 240 barrels of oil per day with a GOR of 2500 SCF:1 BO, a special additional temporary allowable of capacity for newly completed wells, and annual balancing of over and underproduction. Applicants also seek cancellation or make-up of past overproduction. Applicants have also moved to consolidate this case with OCD Case. No. 14613 set for hearing on May 16, 2011.
