10/7/2011

After receiving Koch's notice to oppose, Terry Simcoe sent an email to Morgan Connor and Doug Howard telling them that he would call, as suggested by their attorney, J. Scott Hall, at 2 PM. An immediate response from Mr. Connor asking that the call be postponed until Monday, 10/10, was immediately agreed to by Mr. Simcoe, who replied that he would call Mr. Connor and Mr. Howard at 8:30 AM on Monday 10/10.

10/10/2011

A call was made to Koch at 8:30 AM MDT by Terry Simcoe, COPC landman, and Mike McGovern, CPOC Resource Assessment Manager. The cost allocation procedure was briefly discussed, but seemed to actually not be an issue with Koch. The allocation of production, however, did seem to be a problem for Koch and that was discussed at length. The COPC representatives did not understand Koch's opposition to the proposed plan and it appeared that Koch was thinking that any oil that might be produced from the well would be allocated to the owners on the basis of how much gas might be produced. The COPC representatives assured Koch that oil would be allocated on actual test results, not from results of a gas test by the "spinner method". Koch asked if appropriate language could be put in the proposed operating agreement and COPC readily agreed and asked that Koch submit their desired language as soon as possible. Koch indicated that the language should be sent to COPC before noon on 10/10/2011.

10/11/2011

Terry Simcoe received Koch's proposed production allocation method, not from Koch, but from Koch's counsel, J. Scott Hall, by way of COP's counsel, Tom Kellahin and not until 3 PM, giving very little time for COP to evaluate the proposal and seek approval of the language by COP legal staff.

10/12/2011

COP engineering staff accumulated data on which to form a response to Koch's proposal for production allocation. COP hearing witnesses leave Farmington at 9 AM.
