


P&A Diagram Dorchester Exploration, Inc. Secrest et al #1 Target Re-Entry

1. The maximum injected volume anticipated is 8,000 BWPD. Average anticipated is 6,000 BWPD.
2. Injection will be through a closed system.
3. Maximum injection pressure is expected to be approximately 1,556 psi.
4. Sources will be produced water from Cimarex operated wells in the area. These waters will be compatible with waters in the disposal zone.
5. Water sample analysis from the Yates Petroleum Corp., Santa Fe Land SWD #1 well, below, Sec. 17-T19S-R26E, shows two analyses from the Pennsylvanian Canyon. As the well is a SWD in the Canyon, there is compatibility with the proposed disposal waters.

**Item VIII:**

Disposal will be into the Pennsylvanian Canyon. The lithology is predominately reef-like limestones and/or dolomites with interbedded shales. The interbedded members, both porous and effectively non-porous, are separated by very-low vertical permeability shale beds and/or high-shale carbonates. Limestones of the uppermost Canyon (135' above injection zone) are low porosity ( $\pm 3\%$ ) with interbedded shales. Above these beds the overlying Cisco, 485' thick, is predominately shale with very-tight limestones that also forming excellent barriers to the vertical movement of water. The lower Canyon, beneath the proposed perforations, is tight high-shale limestone approximately 240' thick overlying the Pennsylvanian Shrawn. No zones overlying or below the Canyon are known to contain waters less than 10,000 mg/l.

WATER COLUMN/ AVERAGE DEPTH  
TO WATER

Potable (EPA) water is confined to very shallow depths. RA-01343, above, is a shallow aquifer irrigation well that was last produced in 2004. This is the only well found within 1-mile radius. The original water level (non-artesian) was 69' with well depth of 371' to facilitate coning-water drawdown during pumping. The GR-Neutron log in the Unit D Nearburg well Sec. 18, T19S-R26E, approximately one-mile SE of the proposed SWD, off-setting the above water well, suggests the base of the alluvial fill, the source of the groundwater, is 110'. The alluvium is underlain by eroded Artesia Group. The shallow potable water is adequately protected by cemented surface and intermediate casing in the Secrest et al #1 proposed SWD.

The Secrest et al #1 will be acidized with approximately 10,000 gals 15% HCl acid.

**Item X:**

Logs are on file with the OCD.

**Item XI:**

The one water well within the 1-mile radius of the Secrest et al #1 proposed SWD is discussed in detail in Item VIII above.

The depth to groundwater shown in VIII, above, is 69'.

**Item XII:**

There is no geological evidence of open faults nor hydrologic connection between the disposal zone and any possible underground sources of protectable water.

All potential potable waters, as discussed in VIII and XI, above, will be adequately isolated by casing and cementing.

**Potential of O/G Production from Interval:**

The Canyon formation in the greater area is widely utilized for SWD and has not been observed to be capable of oil or gas productivity.


