STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order: (i) approving a 160-acre non-standard oil spacing and proration unit ("project area") in the Bone Spring formation, comprised of the N½N½ of Section 11, Township 18 South, Range 31 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests from the base of the Second Bone Spring Carbonate to the base of the Bone

Spring formation underlying the non-standard oil spacing and proration unit ("project area") for all pools or formations developed on 40-acre spacing within that vertical extent. The units are to be dedicated to the Tamano 11 Fed. Com. Well No. 1-H, a horizontal well with a surface location in the NE¼NE¼, 400 feet from the north line and 330 feet from the east line, and a bottom-hole location in the NW¼NW¼, 400 feet from the north line and 330 feet from the westline, of Section 11.

Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as the actual operating costs and charges for supervision, designation of applicant as operator of the unit and the well, and a 200% charge for the risk involved in drilling and completing the well.
