By letter dated January 10, 2011 WPX Energy Production, LLC (f/k/a Williams Production Company, LLC), as Cox Canyon Unit Operator, filed the 2011 Plan of Development for the referenced Unit. WPX Energy Production, LLC did not propose any wells under the 2011 Cox Canyon Plan of Development.

The Participating Areas, which have been established in the Cox Canyon Unit, are as follows:






