Page 2 HEARING EXAMINER EZEANYIM: This hearing 1 2 will come to order. Good morning everybody. Today is February 2nd, at approximately 8:15 in the morning. 3 Today we're going to consider Docket Number 4-12. 4 And before I start with the docket, I wanted 5 to make an announcement for the record. The Division has 6 adopted a policy. This policy is unwritten. Anyway, 7 it's important, and we want to communicate it to 8 everybody that continuances are allowed three times only. 9 After the third continuance, the fourth time, the case 10 11 has to be heard or dismissed. So how would that happen? I have been 12 communicating to all of the attorneys. From this hearing 13 today, February 2nd, I've just drawn a line across all 14 15 the cases that have been continued. There were four that were continued for three or four times. Those ones don't 16 17 count. I just drew a line below it. 18 I will say, "First continuance, February 2nd If it's continued again, then that will be second 19 2012." continuance. If it's continued again, that will be third 20 continuance, and that's it. Then it has to be heard in 21 that hearing. If it's going to be continued, then that 22 case will be dismissed. 23 So we want to grandfather all continuances 24 before we start this process. We want to clean up the 25

Page 3 1 docket, because a lot of them have been sitting on the 2 docket for years and we don't know what to do with them. 3 So we want to allow all the operators to decide what they 4 want to do.

One thing you can do is, if you want to 5 continue it, you can continue it for six months, that's 6 one continuance. You can continue it for one year, 7 that's one continuance. If you continue it for two 8 weeks, that's one continuance; one month, one continunce; 9 two months -- so if you think you are not going to use 10 that application, you can continue it for a longer time 11 to decide what you want to do so that it's not dismissed 12 after you continue it for two weeks, three weeks and so 13 forth. So that's how we want to see if we can clean up 14 our docket. 15

Now, as you can see, the room is empty. 16 The first order of business is to continue with the 17 dismissals and continuances on Docket Number 4-12. We go 18 to page 1. On page 1, Case Number 14787 is continued to 19 20 March 1st, and that is the first continuance for this 21 case. Usually they have been continued for a long time. 22 On page 2, Case Number 14746 is continued to March 1st; Case Number 14671 is dismissed; Case Number 23 14754 is dismissed; Case Number 14779 is dismissed. 24 25 On page 3, Case Number 14780 is dismissed;
