APPLICATION OF THE OIL CONSERVATION DIVISION TO AMEND DIVISION ORDER NO. R-13382-E.

CASE NO. 14613 (Reopened) and CASE NO. 14647 (Reopened) ORDER NO. R-13382-H

ORDER OF THE DIVISION

BY THE DIVISION:

These cases came on for hearing on April 26, 2012, at Santa Fe, New Mexico, before Examiner Richard I. Ezeanyim.

NOW, on this 2nd day of May, 2012, the Division Director, having considered the consent of the parties of record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given and the Division has jurisdiction of these cases and of the subject matter.
- (2) Case Nos. 14613 and 14647 were previously consolidated for the purpose of testimony; and one order was issued for both cases.
- (3) On September 8, 2011, the Division entered Order No. R-13382-E ("Order"), consolidating the (1) Cedar Lake-Glorieta-Yeso Pool, (2) Fren-Glorieta-Yeso Pool, (3) East Fren-Glorieta-Yeso Pool, (4) Loco Hills-Glorieta-Yeso Pool and (5) North Maljamar-Paddock Pool into a single pool, designated in the Order as the Mar-Loco-Glorieta-Yeso Pool. *See* Ordering paragraph (3) of Order No. R-13382-E.
- (4) The administrative burdens imposed by the consolidation of these five pools upon the Division, the New Mexico State Land Office, and the New Mexico Taxation and Revenue Department are untenable.
- (5) The Division, therefore, applied on March 27, 2012, to amend the Order for the express limited purpose of abolishing the Mar-Loco-Glorieta-Yeso Pool and in its place re-designating the five separate pools that had been consolidated by the Order.

- (6) Abolishing the Mar-Loco-Glorieta-Yeso Pool renders ordering paragraph (4) in Order No. R-13382-E obsolete and unnecessary.
- (7) The Division does not seek to amend the Special Pool Rules for the five Glorieta-Yeso Pools which comprised the newly formed Mar-Loco-Glorieta-Yeso Pool; those rules will remain in place and will continue to apply to the five Glorieta-Yeso pools.
- (8) All parties of record to these cases have consented to and otherwise approve of the Division's proposed limited amendment.
- (9) Ordering paragraphs (3) and (4) in Order No. R-13382-E should be withdrawn, as they are no longer necessary with the re-designation of the five previously consolidated pools.

IT IS THEREFORE ORDERED THAT:

- (1) The application of the Division to abolish the Mar-Loco-Glorieta-Yeso Pool and in its place to re-designate the five separate pools that had been consolidated by the Order is hereby granted.
- (2) The five pools previously consolidated under Order No. R-13382-E shall be re-designated as they existed before entry of Order No. R-13382-E, as follows:
 - (i) The Cedar Lake-Glorieta-Yeso Pool was created by Division Order No. R-11067, dated November 1, 1998, and currently covers the following lands:


