APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the E/2 W/2 of Section 8, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso formation

underlying this acreage to form a 160-acre project area in this formation. COG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed Bradley 8 Fee 2H Well (API #30-015-39811), to be horizontally drilled from an orthodox surface location 150 feet from the South line and 1700 feet from the West line (Unit N) to an orthodox bottom hole location 330 feet from the North line and 1700 feet from the West line (Unit C) of Section 8.
