Dear Tommy Roberts,

Your client, Marrion Oil and Gas Corp., has failed to provide the name and address of their escrow agent in to the Oil Conservation Division (OCD), as mandated by each case's associated Order. The general form of the order is as follows:

*Except as provided in Paragraphs (xx) and (xx) above, all proceeds from production from the proposed wells that are not disbursed for any reason shall be placed in escrow in [the appropriate county], New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division (Attention: OCD Records Clerk) of the name and address of the escrow agent not later than **one year** from the date of issuance of this Order.*

Since the due date to provide the mandated information has passed, **each company is to furnish the name and address of the escrow agent before July 18, 2012, to the following:**
