Applicant seeks an order pooling all mineral interests from the surface to the base of the Glorieta-Yeso formation underlying the NW/4NE/4 of Section 6, Township 19 South, Range 26 East, NMPM, to form a standard 40-acre oil spacing and proration unit for any and all formations or pools developed on 40-acre spacing within that vertical extent. The unit will be dedicated to the Illinois 6 Fee Well No. 1, to be drilled at an orthodox location. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Cimarex Energy Co. of Colorado as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 5 miles south-southwest of Atoka, New Mexico.

The unit will be dedicated to the Illinois 6 Fee Well No. 2, to be drilled at an orthodox location. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Cimarex Energy Co. of Colorado as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. Applicant in the above-styled cause seeks an order (1) creating a non-standard 160-acre spacing and proration unit comprised of the N/2 S/2 of Section 2, Township 17 South, Range 29 East, NMPM, and (2) pooling all mineral interests in the Yeso formation, underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Hogan State Com #2H Well, to be horizontally drilled from a surface location 1650 feet from the South line and 330 feet from the East line (Unit I) to a bottom hole location 1650 feet from the South line and 330 feet from the West line (Unit L) of Section 2. The completed interval for this well will be within the 330-foot standard offset required by the rules. Said non-standard unit is to be dedicated to applicant's proposed Hogan State Com #4H Well, to be horizontally drilled from a surface location 330 feet from the South line and 330 feet from the East line (Unit P) to a bottom hole location 330 feet from the South line and 330 feet from the West line (Unit M) of Section 2. The completed interval for this well will be within the 330-foot standard offset required by the rules. Applicant seeks an order pooling all mineral interests in the SW/4 NE/4 of Section 16, Township 17 South, Range 31 East, NMPM, Eddy County, New Mexico, to form a standard 40-acre spacing and proration unit for any and all formations and or pools developed on 40 acres from the surface to the base of the Glorieta-Yeso formation, Mar Loco Glorieta Pool (79866). The referenced unit will be dedicated to the Burkett 16 State No. 1 Well to be drilled at a standard location 1650' from the North and East lines of Section 16. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of COG Operating LLC as operator of the well and a charge for risk involved in drilling the well. The proposed well location is approximately 6 miles northeast of Loco Hills, New Mexico.
