#### STATEMENT OF THE CASE

COG Operating LLC seeks an order (1) creating a non-standard, 160-acre spacing and proration unit comprised of the S/2 S/2 of Section 2, Township 17 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Yeso formation underlying this acreage to form a 160-acre project area in this formation. COG proposes to

dedicate the above-referenced spacing a proration unit as the project area for its proposed Hogan State Com 4H Well, which it will drill to a depth sufficient to test the Yeso formation from a surface location 330 feet from the South line and 330 feet from the East line (Unit P) to a bottom hole location 330 feet from the South line and 330 feet from the West line (Unit M) of Section 2. The completed interval for this well will be within the 330-foot standard offset required by the rules.
