1 MADAME CHAIR: We have one person in the
2 audience today, Ocean is here with us. It is 9 o'clock.
3 This is a meeting of the Oil Conservation Commission on
4 Wednesday, July 18th in Porter Hall in Santa Fe,
5 New Mexico. I am Jami Bailey, Chairman of the
6 Commission. To my right is Scott Dawson, who is the
7 designee of the Commission of Public Lands. And
8 participating by telephone is Dr. Robert Balch.
9 Commissioner Balch is the designee of the Secretary of
10 the Energy, Minerals, and Natural Resources Department.

11 We are here today on the docket. We have case
12 14763, which is the application of the Mack Energy
13 Corporation for compulsory pooling in Lea County,
14 New Mexico. That case has been continued until the
15 September 13th, 2012 Commission meeting.

16 We also have case 14764, which is the application
17 of Cimarex Energy Company of Colorado for approval of a
18 non-standard oil spacing and proration unit, an
19 unorthodox location and compulsory pooling in Lea
20 County, New Mexico. That case has been continued until
21 the August 16th, 2012 commission meeting.

22 We have minutes of the previous meeting that was
23 held June 20th through the 22nd. Have the Commissioners
24 had a chance to look over the draft minutes of that
25 meeting?

1 COMMISSIONER DAWSON: I have.

2 MADAME CHAIR: Do I hear a motion and a
3 second to approve the minutes of that meeting?

4 COMMISSIONER DAWSON: I will motion.

5 COMMISSIONER BALCH: And I will second.

6 MADAME CHAIR: All those in favor? Aye.

7 COMMISSIONER DAWSON: Aye.

8 COMMISSIONER BALCH: Aye.

9 MADAME CHAIR: Then I will sign the minutes
10 of that meeting on behalf of the Commission. We also
11 have minutes of the meeting of the Commission that was
12 held on June 27th, 2012. Commissioners, have you had a
13 chance to look over this draft of the minutes?

16 MADAME CHAIR: Do I hear a motion and a

15 And, finally, we have an order for reopened case
16 number 14720, which was the application of Agave Energy
17 Company for authority to inject in Lea County,
18 New Mexico. Commissioners, have you had a chance to
19 review the draft order of that case?

20 COMMISSIONER DAWSON: I have.

21 COMMISSIONER BALCH: And I have as well.

22 MADAME CHAIR: Do I hear a motion for
23 adoption of the order Number R13507A for case number
24 14720?

25 COMMISSIONER DAWSON: I will motion.

1 COMMISSIONER BALCH: And I will second.

2 MADAME CHAIR: All those in favor of
3 adopting this order signify by saying aye. Aye.

4 COMMISSIONER DAWSON: Aye.

5 COMMISSIONER BALCH: Aye.

6 MADAME CHAIR: Commissioner Dawson and I
7 will sign this order in person and mail it to
8 Commissioner Balch for his signature. And all documents
9 are being transferred to the Commission secretary.

10 Do we have any other business before the
11 Commission today? Then do I hear a motion to adjourn
12 this meeting?
