Dear Mr. Nygaard:

With reference to our recent discussion, please find enclosed two (2) copies of an Oil and Gas Lease and Memorandum of Oil and Gas Lease covering the Daisy Keith Trust mineral interest under the captioned lands. Also enclosed is a W-9 form for your completion and return. The lease form is the Northern Trust form used by Elloine M. Clark. As discussed, the lease offer is as follows:

- 1) A bonus consideration of \$200.00 per net mineral acre, being a total bonus of \$2,000.00 ( $1/32 \times 320 \times \$200.00$ ).
- 2) A lessor royalty of  $1/4^{\text{th}}$ .
- 3) A three (3) year primary term.

If the lease form and offer is acceptable, please execute one copy of both the Lease and Memorandum in the presence of a Notary Public and return both along with the W-9 form in the enclosed envelope. We have made deletions of certain language in paragraphs 9, 13 and 19 which do not apply in this situation. Please initial in the margin where indicated. Also, enclosed is a partial copy of our title opinion which requires that we be furnished with a copy of the Trust agreement and a letter from the Trustee confirming that the Trust is still in existence and that you have authority to deal with the mineral interest. Also, please furnish a copy of the Will and death certificate for Daisy Keith if available.

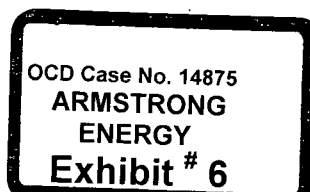
