#### APPLICATION

Mewbourne Oil Company applies for an order (i) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the S½S½ of Section 3, Township 20 South, Range 29 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

1. Applicant is an interest owner in the  $S\frac{1}{2}S\frac{1}{2}$  of Section 3, and has the right to drill a well thereon.

2. Applicant has drilled its Sharps 3 Fed. Com. Well No. 2 to a depth sufficient to test the Bone Spring formation. Applicant seeks to dedicate the  $S\frac{1}{2}S\frac{1}{2}$  of Section 3 to the well to form a non-standard 160 acre oil spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing within that vertical extent. The well is a horizontal well, with a surface location in the SE<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub>, and a terminus in the SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub>, of Section 3.

3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the  $S\frac{1}{2}S\frac{1}{2}$  of Section 3 for the purposes set forth herein.

4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners in the S½S½ of Section 3, pursuant to NMSA 1978 §§70-2-17, 18.

5. Approval of the non-standard unit and the pooling of all mineral interests underlying the  $S\frac{1}{2}S\frac{1}{2}$  of Section 3 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

A. Approving a non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the  $S^{1/2}S^{1/2}$  of Section 3;

B. Pooling all mineral interests in the Bone Spring formation underlying the  $S\frac{1}{2}S\frac{1}{2}$  of Section 3;

C. Designating applicant as operator of the well;

E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

F. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.
