Dear Commissioners Bailey, Balch and Bloom,

I have lived and voted in New Mexico for over twenty-five years. I am deeply concerned about the health of our environment, how it affects the lives of New Mexicans, our economy, our future. The New Mexico pit Rule was enacted to prevent unlined drilling pits. The changes proposed by the oil and gas industry will weaken the present pit rule to become among the least strict in the United States.

I am very concerned that these proposals that weaken the Pit Rule which was a collaborative process and included heavy input from the oil and gas industry, will open the door for abuses that will include pits the size of lakes. These are already existent in Texas and Colorado. The proposed changes would open the door to the use of temporary disposal pits for up to a year, allowing companies to log their pits within their own records with out oversight, allowing higher levels of poisonous chlorides in the pit waste. The industry did not present ANY evidence that the Pit Rule is impossible to comply with, overly burdensome, or that it does not protect the environment.

Prior to the rule's implementation four years ago, New Mexico had at least 400 cases of groundwater contamination from oil and gas development. Since the Pit Rule, there have been zero. Please tell the commission not to cave to industry pressure and to continue ensuring a high standard for our beautiful state's land and water.

Please DO NOT roll back the requirements of the Pit Rule.

As you know, the New Mexico Pit Rule was enacted to prevent unlined drilling pits. Prior to the rule's implementation four years ago, New Mexico had at least 400 cases of groundwater contamination from oil and gas development. Since the Pit Rule, there have been zero.

If the oil and gas industry's petition to roll back the requirements of the Pit Rule is granted, the regulations of oil and gas development in New Mexico will shift from being among the strictest in the country to being among the least strict. The companies see an opportunity to assert their power over the political process, even when there is no logical reason to overturn the rule. There is no justification for their request except avarice and a play for power. The welfare of our state and of our citizen's does not concern their underlying lust for financial gain.
