It is imperative that we maintain this rule as it is. In the southwest, water is a rare enough necessity now. With growing populations and shrinking water supplies due to usage, climate change and occasional pollution of underground water sources we face fewer and fewer sources. As an example, we have the aviation fuel plume in Albuquerque from Kirtland AFB. This has been going for up to 50 years and as it approaches a City well field they may be facing some expensive alternatives. The fact that the Air Force may have to share the costs is nearly irrelevant - the most important point is that the aquifer may be lost. It is more important to take the steps necessary to PREVENT than to take expensive and incomplete steps after the avoidable incident that begins the slow degradation of the limited water supplies.
