

Re: Comments on NMOGA and IPANM Proposed Amendments to 19.15.17 and 19.15.39.8 NMAC.

Dear Ms. Davidson:

I have reviewed the proposed amendments and have the following comments:

#### 19.15.17.7 Definitions.

<u>"Playa lake" means a dry, barren area in the lowest part of an undrained natural desert basin underlain by clay, silt, or sand and commonly soluble salts.</u>

This proposed definition has no scientific basis. Playa lakes are in reality ephemeral wetlands, meaning they sometimes contain water, vegetation and aquatic life; thus, they are not "dry and barren." The substrate is clay, not "silt or sand". The proposed definition seems to imply that these waters are not worth protecting. A scientific definition should be adopted instead.

#### 19.15.17.10 Siting requirements.

The proposal removes all protections for sinkholes, playas and intermittent waters; and drastically reduces the protective depths to groundwater. Sinkhole lakes are fed by ground water and thus are directly affected by ground water quality. Playa lakes are essential wildlife habitat and during periods of drying, the substrate allows infiltration of water on the surface to recharge groundwater. Santa Rosa and Roswell derive economic benefit from the recreational opportunities provided by sinkhole lakes such as Blue Hole and the Bottomless Lakes State Park. Protections for non-flowing surface waters must be retained.

#### 19.15.17.15 Exceptions and variances.

The proposal shifts the burden of proof of public health and environmental protection to the state. The operator is best equipped to provide this information. Taxpayers should not have to bear the costs incurred by private business.

#### 19.15.39.8.B.

The proposal would allow siting of pits in the largest remaining tract of Chihuahuan desert in the U.S. This area was set aside due to its ecological significance and vulnerable groundwater. These rules were developed after vast time and effort by many citizens and scientists and should remain.

The Oil Conservation Commission adopted the current pit rules after 18 months of discussion from industry, environmental experts, citizens, scientists and regulatory agencies. By contrast, the proposed amendments were developed by only "New Mexico oil and gas companies" over "several months" (see attached press release). By this measure alone, it appears the existing rules are preferable for all stakeholders.

The petitioners claim that "project funding that has been going to other states." However, there is no economic evidence to support this claim. The petitioners claim that the changes are "based on sound science, maintain environmental safeguards, and encourage environmentally responsible energy development..." none of which the proposal appears to do. The petitioners claim that the proposed amendments will make it easier to conduct oil and gas activities. In fact, the removal of technical, measurable requirements will actually make it more difficult for operators to understand and comply with regulations, and result in a bottleneck of debate and litigation.

The proposed amendments pose a serious threat to surface and groundwater and are not in the best health, economic and environmental interests of New Mexican citizens.

The New Mexico Oil & Gas Association today filed proposed changes to Rule 19.15.17 of the New Mexico Administration Code, commonly referred to as the "pit rule." The changes are designed to make the oil and gas industry in New Mexico competitive with surrounding states for new drilling and development while maintaining groundwater and environmental protections.

The changes, if approved, will encourage additional drilling by allowing lined production pits and on-site burial of drilling cuttings where the distance to groundwater is sufficient for these activities to be performed in a manner that is protective of the environment. In addition, the proposed changes provide for updates to the rules governing siting criteria, construction and closure of below-grade tanks and other facilities.

"By allowing for the use of lined drilling pits and in-place burial of drilling cuttings when they can be used safely, New Mexico's oil and gas industry will be drilling more wells, adding more employees and paying more taxes," said Jason Sandel, Chairman of the New Mexico Oil & Gas Association.

The proposed changes to the highly technical rule were developed with input by a wide range of New Mexico oil and gas companies under a set of criteria for the changes including: changes must be based on sound science, changes must maintain environmental safeguards, and changes must encourage environmentally responsible energy development and the resulting jobs and tax revenues.

I am writing to submit my comments in regard to the applications submitted by the Independent Petroleum Association of New Mexico (IPANM) and the New Mexico Oil & Gas Association (NMOGA) to alter New Mexico's "Pit Rule."

I strongly support the existing Pit Rule, and urge the Oil Conservation Division to deny these petitions, which are designed to weaken it.

The Pit Rule includes important measures that protect public health and the environment, including:

- Requiring closed-loop systems of water used for drilling and production in many instances;
- (2) Care Requiring that temporary lined, low chloride wasterpits be at least 500 feet from the 12 graph of groundwater, domestic wells, springs, and wetlands—not the 100 feet requested by the 2 red continuatry; as year more at a personal personal continuation of the continuation of t
- Prohibiting burial of mud wastes on-site (which the State Land Office has rightly compared to illegal dumping);
- Defining "low chloride salt drilling fluid" as concentrations of 3,000 milligram/liter or less (just as Texas and Wyoming do)—not the 15,000 mg/liter or less requested by the industry, which would endanger groundwater quality by encouraging disposal of toxic oil field wastes in numerous uncontrolled locations; and
  - Requiring administrative proceedings for variances from the rule, rather than automatically allowing any variances unless the Oil Conservation Division can prove that they would result in harm to water quality, public health, or the environment.

The existing Pit Rule was adopted after a thorough 18-month process—including 17 days of public hearings—that considered input from a wide range of stakeholders. I am troubled that, in its consideration of the current IPANM and NMOGA petitions, the Oil Conservation Division is refusing to admit into evidence the approximately 8,000 pages of testimony and exhibits from those earlier hearings. This record includes extensive technical and economic evidence supporting the adoption of the existing Pit Rule.

By contrast, during last month's hearings the petitioners did not present any evidence to support their allegations that the Pit Rule is overly burdensome, prohibitively expensive, or unnecessary to protect the environment. In fact, although oil and gas drilling in all western states declined in

2008 due to the global recession, the drill count in New Mexico has rebounded faster than in other states. According to a report by Baker Hughes, between April 2009 and December 2010 the number of rigs in New Mexico increased by 130%, from 30 to 69 rigs, compared to smaller increases in Colorado (20%), Wyoming (30%), and Texas (95%) during the same time period.

Other western states are moving to adopt more environmentally protective standards, similar to New Mexico's existing Pit Rule. If the IPANM and NMOGA petitions are granted, New Mexico's regulation of oil and gas development will go from being among the most protective in the country to being among the least protective. This would truly be a step backward for New Mexico's people, wildlife, and natural landscape.

A May 6, 2012 article by the Santa Fe New Mexican noted that while New Mexico has over 100,000 oil and gas wells, it has fewer than 100 inspectors to monitor them. The article states that, "... with so many wells to check, [the inspectors] are lucky to get to each well once every three years." With such infrequent inspections, the Pit Rule serve as a critical safety net to ensure that oil and gas drilling occurs in a responsible manner that adequately protects public health and the environment.

The existing Pit Rule works. Prior to the rule's implementation four years ago, New Mexico experienced at least 400 cases of groundwater contamination from oil and gas development, according to data released by the Oil Conservation Division. (In addition, the Division's Environmental Bureau reported that between the mid-1980s and 2003, there were nearly 7,000 instances in which pits caused soil and water contamination.) Since the Pit Rule took effect, the number of incidents of groundwater contamination has fallen to zero.

As a New Mexican who values clean water, I urge the NMOCD to deny the IPANM and NMOGA applications to weaken the Pit Rule. Please leave the rule on the books as it is currently written.
