- MR. EXAMINER: Good morning, everybody.
- 2 This hearing will come to order. We're going to go into
- 3 the docket. I want to make a brief announcement for the
- 4 general consumption. Take a seat, take a seat.
- 5 As you all know, we have a new rule and it's in
- 6 effect now and there are certain implementations that we
- 7 need to make sure that you understand. From now on
- 8 whenever you are presenting an interval well, you know,
- 9 something like from that kind of a case, I would
- 10 appreciate it if you could give us the well construction
- 11 diagram at the hearing so that we know where the
- 12 completed interval is at.
- As you all know, a completed interval is a new
- 14 term where we implemented a new rule. It's not just for
- 15 this area. Therefore, you can present the well any way
- 16 you want it as long as you give us the construction and
- 17 tell us where the completed interval is. That would be
- 18 really appreciated.
- Most of the cases we have today, the information
- 20 is for that area and the drilling of the well. And you
- 21 may not have that well complete and you may submit after
- 22 the hearing. But I want you to do it to make sure that
- 23 you present the well construction in the area and not
- 24 after the fact.
- As you all know, this is a new rule and it might

- 1 be subject to interpretation. Here we have a technical
- 2 examiner to help you; Mr. Brooks is here. And we can
- 3 also help you with any technical interpretation that you
- 4 may have in trying to comply with that rule or trying to
- 5 present your case before the OCD or the OCC, whatever
- 6 the case may be. So if you need any interpretation
- 7 please let us know. We did one on Monday, and we would
- 8 appreciate it if you understand how they can implement
- 9 the project. I really liked it. We are working with
- 10 you.
- Okay. And I want to remind everybody, I have a
- 12 full house today, about the new policy that was put in
- 13 place just this February about this issue of continuing
- 14 applications and the cases dismissed without prejudice.
- 15 So I want to make sure everybody understands that some
- of the cases stay on the docket for years and then it's
- 17 crossed off the docket.
- 18 And the recommended decision is that we need to
- 19 continue for only three times or four times and then it
- 20 has to be heard or dismissed without prejudice. So I
- 21 want to make sure -- I think I told you that we
- 22 grandfathered any continuances before February 2nd. So
- 23 if you are continued for 10 times or 20, it didn't
- 24 count. So whenever you think your case has been
- 25 continued for three times, please make sure you prepare

- 1 to get it heard or dismiss it yourselves or we will
- 2 dismiss it for you without prejudice.
- 3 You know, I talked about an example that I see of
- 4 what is going on in the field about operations, how
- 5 negotiations are going on. I see one thing placed on
- 6 you, the fact that we would like you to, you know,
- 7 negotiate. So coming to the hearing and if you actually
- 8 come to the hearing, because you have the right. Of
- 9 course you have the right to come to a hearing. Nobody
- 10 is saying don't come to the hearing.
- But in the interest of similar processes I would
- 12 appreciate it if you guys can try to negotiate. And
- 13 when it's broken down in negotiations come to the
- 14 hearing. Not everything is coming to the hearing and
- 15 then the docket is closed out that we are -- you know,
- 16 we have short staff. We don't have enough to deal with
- 17 every process of the case that you may have that could
- 18 have been settled if you negotiate the case. So I
- 19 always talk about this. And I think it helps you so
- 20 much if you bring it to the hearing, we decide it, and
- 21 you may not like it. So I encourage you to negotiate
- 22 among yourselves.
- Now I wanted to say, are there any questions or
- 24 comments? Anything that anybody can do or any questions
- 25 that we can handle?

- Okay, then we're going to call today's docket.
- 2 Today is April 26th and we're going to call Docket
- 3 Number 13-12. And first order of business is to call
- 4 the dismissals and continuances.
- 5 On page 1, case 14657 is dismissed. On page 2,
- 6 case number 14814 is continued to May 10th. Then go to
- 7 page 4, case number 14810 is dismissed. All the cases
- 8 from case number 14819 up to 14824, all those cases are
- 9 continued to May 10th; 14819, 14820, 14821, 14822, 14823
- 10 and 14824 are all continued to May 10th.
- On page 5, case number 14825 is continued to
- 12 May 10th. Case number 14826\is continued to May 10th.
- 13 Case number 14828 is dismissed. Page 6, case number
- 14 14829 is dismissed. Case number 14830 is dismissed. On
- page 7, case number 14687 will be dismissed without
- 16 prejudice. And I want to read this out for the record
- 17 to tell you what I just said about continuing for three
- 18 times and then four times they continue the hearing. So
- 19 it had to be dismissed without prejudice.
- Let me read it into the record, the case that
- 21 will be dismissed without prejudice. This is
- 22 application of Cimarex Energy Company for a non-standard
- 23 oil spacing and proration unit and compulsory pooling
- 24 for, Chaves County, New Mexico will be dismissed without
- 25 prejudice.

- 1 On page 8, case number 14804 will be dismissed.
- 2 And are there any other dismissals at this time?
- 3 MR. RANKIN: Mr. Examiner, Adam Rankin on
- 4 behalf of OXY USA. We'd like to dismiss case 14798.
- 5 MR. EXAMINER: What page? What page?
- 6 MR. RANKIN: It's on page 4.
- 7 MR. EXAMINER: 14798, correct.
- 8 MR. RANKIN: That's correct, to dismiss.
- 9 MR. EXAMINER: Dismissed, okay. Let the
- 10 record reflect that case number 14798 is dismissed.
- MR. BRUCE: Mr. Examiner, on page 4 at the
- 12 top, I can't remember if you got this case or not. But
- 13 the Mewbourne Oil Company case 14810, that should be
- 14 dismissed.
- MR. EXAMINER: Yes, I didn't say that. Any
- 16 other dismissals.
- Case number 14798, yes, I'm going to take it from
- 18 the pile. I don't have to hear it anymore.
- Any other dismissals, continuances? Now what we
- 20 are going to do, we have a bunch of cases today, much
- 21 are contested. So what I will do first is to call case
- 22 number 14812. That case, we're not going to hear it
- 23 today. We heard it last time and I just need to call it
- 24 to collect some new information.
- 25 And then we have two cases, 14613 and 14647, then
