3 Cimarex Energy Company of Colorado for compulsory
4 pooling, Eddy County, New Mexico.

5 Call for appearances.

6 MR. BRUCE: Mr. Examiner, Jim Bruce of
7 Santa Fe representing the Applicant. I'm submitting
8 this one by affidavit, also.

9 This is similar. I've handed you Exhibit
10 1, an affidavit by the landman. If you turn to the --
11 this also involves Section 1 of 19 South, 25 East, where
12 Cimarex seeks to force pool 240-acre well units for two
13 wells in the west half-southwest of Section 1. And both
14 of these cases working -- these are Yeso wells.
15 Interest ownership is common throughout the reported
16 depths. And, again, there is a prior pooling order,
17 which is 13589.

18 And again, afterwards, Cimarex desired to
19 make sure that everyone was tied up, so they -- we seek
20 to force pool Don Phillips and Associates, James Collie
21 McDonald, Jr., Jo Alice Cranford, Hugh M. Kincaid and
22 Elaine S. Hinkle. Again, they have been unable to
23 locate these people or been unable to determine whether
24 or not all of the successors in interest have been
25 leased. And no New Mexico probates have been conducted,

1 and, again, there are no affidavits of heirship. And
2 we're merely seeking to force pool the possible heirs or
3 devisees or successors of these people.

4 Exhibit 2 is the publication in the
5 Carlsbad newspaper giving notice to all these
6 unlocatable people.

7 So I move to admit Exhibits 1 and 2.

8 EXAMINER BROOKS: 1 and 2 are admitted.

9 (Cimarex Energy of Colorado Exhibit Numbers
10 1 and 2 were offered and admitted into
11 evidence.)

12 MR. BRUCE: That's all I have,
13 Mr. Examiner.

14 EXAMINER BROOKS: Very good. Case Number
15 14901 will be taken under advisement.
