#### Dear Paul:

MYCO Industries, Inc. (MYCO) recently drilled its Boise Federal #1 in Unit H of Section 35, T21S, R27E as a 12,000' Morrow well (see attached plat). We have not been very successful in the Morrow so we are making plans to further test the well and will eventually plug back to test the Wolfcamp formation.

There is a currently a Wolfcamp well located in Unit B (Reeves Fed #1) of Section 35. In order to produce the Wolfcamp in its well, MYCO must seek exception to Division Rule 104.C(2)(b) which provides that only one infill well on a 320-acre unit shall be allowed provided that the well is located in the quarter section of the 320-acre unit not containing the initial well.

Furthermore, the operator of the Reeves Fed #1 is Delta Petroleum Corporation ("Delta"). Delta and MYCO have an agreement which allows MYCO to operate the Boise Federal #1 but MYCO must seek an exception to Division Rule 104.C(2)(c) which provides that the division-designated operator for the infill well is the same operator currently designated by the division for the initial well.

MYCO respectfully request that as an offset operator, you waive objection to our application for exception to Division Rule 104.C(2)(b) and (c). Should you wish to discuss any of these issues, feel free to call us at 505.748.4290 or simply sign, date and return one copy of this letter.
