WHEREUPON, the following proceedings were had at 1 2 9:05 a.m.: CHAIRMAN FESMIRE: At this time we'll call to 3 order the Thursday, June 9th, 2005, meeting of the New 4 Mexico Oil Conservation Commission. Let the record reflect 5 that the location of the meeting is Porter Hall in the Oil 6 7 Conservation Division office in Santa Fe, New Mexico, and the time is 9:05 a.m. 8 My name is Mark Fesmire, I'm Chairman of the 9 Commission. 10 To my right is Commissioner Jami Bailey. 11 Commissioner Bailey is the designee to the Commission of 12 State Land Office Commissioner Patrick Lyons. 13 To my left is Commissioner Frank Chavez. 14 Commissioner Chavez is the former OCD supervisor in Aztec 15 and the appointee of the NM EMNRD Secretary, Joanna Prukop. 16 17 The counsel for today's meeting for the 18 Commission is Cheryl Bada, and the Secretary is -- as it 19 has been for quite a length of time -- is Florene Davidson. The court reporter today is Mr. Steve Brenner. 20 21 Let the record reflect that a quorum of the Commissioners or their designees are present. 22 The first matter of business before the 23 24 Commission is the adoption of minutes of the last meeting, 25 held on Thursday, May 12th, 2005.

Have the Commissioners had the opportunity to 1 review the minutes of the meeting? 2 COMMISSIONER BAILEY: Yes, I have, and I move 3 that we adopt them. COMMISSIONER CHAVEZ: I second the motion. 5 CHAIRMAN FESMIRE: The minutes, having been 6 reviewed by the Commissioners and a motion to adopt the 7 minutes is before the Commission, all those in favor? 8 COMMISSIONER BAILEY: 9 Aye. COMMISSIONER CHAVEZ: 10 Aye. CHAIRMAN FESMIRE: Opposed? 11 The minutes are adopted, and we'll take a couple 12 of seconds to sign them. 13 Let the record reflect that the minutes have been 14 15 signed and transmitted to Secretary Davidson for recording. * * * 16 17 CHAIRMAN FESMIRE: The docket today consists 18 first of Cause Number 13,061, it's the Application of the 19 New Mexico Oil Conservation Division through the 20 Environmental Party [sic] Chief, for an order determining 21 the responsible party or parties and ordering the 22 23 responsible party or parties to complete and perform an abatement plan pursuant to OCD Rule 19, Lea County, New

Mexico.

This matter came before the Commission last month 1 and was heard, the parties were represented. 2 At this time I'll turn it over to Counsel Bada to 3 bring the Commission up to speed on where we stand on 4 the... 5 MS. BADA: Okay, an order has been drafted 6 pursuant to the Commission's decision at the last meeting, 7 and it finds that Smith and Marrs is the responsible party, 8 and it imposes a fine of \$197,000, a third of that which 9 can be waived if Smith and Marrs completes the Stage 1 10 abatement investigative report within six months from the 11 date of the order, and another third can be waived if they 12 complete the Stage 2 abatement as directed by the Division 13 upon completion of a Stage 1 investigative report. 14 CHAIRMAN FESMIRE: Commissioner Bailey, have you 15 had the opportunity to review the order as drafted? 16 17 COMMISSIONER BAILEY: Yes, I have, and I expect 18 to sign it. 19 CHAIRMAN FESMIRE: Okay. Commissioner Chavez, 20 have you had a chance to review it? 21 COMMISSIONER CHAVEZ: Yes, I have, and I will sign it. 22 23 CHAIRMAN FESMIRE: And I too will sign the order. I think it reflects the Commission's decision. 24 25 At this time we'll take a few minutes to sign the

1 order. Let the record reflect that all three 2 Commissioners have signed the order, and it has been 3 transmitted to Secretary Davidson. 5 6 CHAIRMAN FESMIRE: The only other case on the 7 8 docket today is Cause Number 13,402. It was continued from the May 12th, 2005, Commission meeting. 9 We have received a motion to continue it again 10 from the attorney representing the Applicant, Loco Hills 11 GSF. Would the Commission have any objection to continuing 12 this to the next meeting? 13 COMMISSIONER BAILEY: 14 No. 15 COMMISSIONER CHAVEZ: No objection. CHAIRMAN FESMIRE: Okay. With that, the case 16 17 Number 13,402 will be continued as requested by their attorney. 18 19 And that's the last item on the agenda for today. 20 Is there any other business before the 21 Commission, that the Commissioners are aware of, that we need to address today? 22 23 COMMISSIONER BAILEY: No. 24 COMMISSIONER CHAVEZ: No.
