STATEMENT OF CASE

APPLICANT

Applicant in the above-styled cause seeks an exception to the well density requirements of Rule I.B of the Special Rules and Regulations for the Blanco-Mesaverde Gas Pool to permit it to produce the following two Mesaverde wells located in the same quarter-quarter section (SE/4 NE/4) on a standard spacing and proration unit comprised of the East half of Section 28, Township 32 North, Range 10 West, NMPM:

- the Holmberg Gas Com Well No. 1R (API No. 30-045-29299) which was directionally drilled from a surface location 990 feet from the North line and 1710 feet from the East line (Unit B) to a bottomhole location 1847 feet from the North line and 823 feet from the East line (Unit H) of said section, and
- the Holmberg Gas Com Well No. 1B (API No. 30-045-30270) located 2200 feet from the North line and 1220 feet from the East line (Unit H) of the section.

Said wells are located approximately 12 miles northeast of Aztec, New Mexico.


