

Gentlemen:

In compliance with Section 10 of the Poker Lake Unit Agreement, dated July 16, 1952, Perry R. Bass, as Unit Operator, hereby submits for your approval a Plan of Development for 1976.

History of Development

The past development of this Unit has consisted of 41 wells drilled to test unitized substances within the boundaries of the Unit.

We are presently attempting completion of Poker Lake #44 located 1980' FNL & 2080' FEL of Section 10-T25S-R30E. Further, Poker Lake #43, located 660' FS&WL of Section 21-T24S-R31E, should be spudded before the end of 1975.

Future Development

On May 8, 1975 we filed for a Federal Power Commission Certificate covering our sale of gas from the Poker Lake #42 well to Natural Gas Pipeline Company of America. As of this date, the Federal Power Commission has not granted the Certificate. However, as soon as possible after the Certificate is received,

we will place this well on stream and will observe its production history for any warranted offsets.

Subject to the completion of Poker Lake Well #44, we plan to drill another similar test at a location to be determined upon completion of #44. Further, we plan on conducting approximately 10-15 miles of additional detail seismic within the boundaries of the Unit in hopes of selecting another location for a test in the southern portion of the Unit. We anticipate completing Poker Lake #43 in the first quarter of 1976.

Additional Development

This Plan of Development shall constitute the drilling obligations of the Unit Operator under the terms of the Poker Lake Unit Agreement ending December 31, 1976. Before this Plan expires, a subsequent Plan of Development will be forwarded for your approval.

Modification

It is understood that this Plan of Development shall be effective as of January 1, 1976. If this Plan meets with your approval please indicate in the appropriate space and return one copy for our file.

Gentlemen:

Reference is made to the Poker Lake Plan of Development submitted by Perry R. Bass, as Unit Operator for 1975, which is in compliance with Section 10 of the Poker Lake Unit Agreement.

We hereby respectfully request your favorable consideration of an amended Plan of Development for the Poker Lake Unit for 1975. This Amended Plan is necessitated because of changed conditions since the filing of the original Plan dated December 12, 1974 and to protect the interests of all parties to the subject Unit Agreement.

We propose amending the Future Development section of said Plan of Development to provide for the following:

1. Bass has completed the running of production casing on the Poker Lake #44 located 1980' FNL & 2080' FEL of Section 10-T25S-R30E.
2. We plan to spud Poker Lake #43 located 660' FS&WL of Section 21-T24S-R31E, on December 23, 1975, and drill to a depth to adequately test for unitized substances.
