Gentlemen:

By letter of January 30 we acknowledged receipt on January 28, 1963, of a ratification and joinder to the Poker Lake unit agreement and unit operating agreement, Eddy County, New Mexico, executed by William A. Hudson and Edward E. Hudson, leasees of record and working interest owners of lease Las Cruces 069108, unit tract No. 47. Our letter advised that lease Las Cruces 069108 is considered effectively committed to the Poker Lake unit agreement as of February 1, 1963.



Gentlemen:

In compliance with Section 10 of the Poker Lake Unit Agreement, dated July 16, 1952, Perry R. Bass, as Unit Operator, hereby submits for your approval Plan of Development covering the period from June 1, 1963 to June 1, 1964.

History of Past Development

In reviewing the past development of the Poker Lake Unit, we are attaching hereto a map marked "Exhibit A" which reflects all of the wells drilled within this Unit Area since its inception. You will note that the deep tests are marked in red, all of which wells were drilled below 13,500 feet. The Richardson & Bass No. 1 Harrison, which was completed as a dry hole May 22, 1954, was drilled to a total depth of 16,705 feet. This well was drilled in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12, Township 25 South, Range 30 East. The next deep test was located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 1, Township 25 South, Range 30 East, and was completed as a dry hole September 5, 1955 at a total depth of 13,792 feet. The third deep test was drilled in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 22, Township 25 South, Range 30 East, and was completed on March 24, 1956 at a total depth of 14,883 feet. In addition to the deep tests as outlined above, there have been 28 wells drilled within the Unit Area as of June 1, 1963. These tests varied in depth from 3,500 to 4,500 feet and, as reflected on the plat, have been scattered throughout the Unit in an effort to find Delaware and Lower Delaware production.

A review of our previous Plan of Development calls for three wells to be drilled in the period from June 1, 1962 to June 1, 1963, and we actually

drilled, or caused to be drilled, seven wells during that period, which wells are reflected on the attached exhibit. We are at the present time continuing our geological studies and correlating our sub-surface data on the basis of the seven wells drilled last year with the anticipation that other productive areas will be found within the Unit Area.

Development

Perry R. Bass, as Unit Operator, plans to drill, or cause to be drilled, at least two additional wells in the period from June 1, 1963 to June 1, 1964.

Effective Date

This Plan of Development shall be effective June 1, 1963 and expire June 1, 1964.

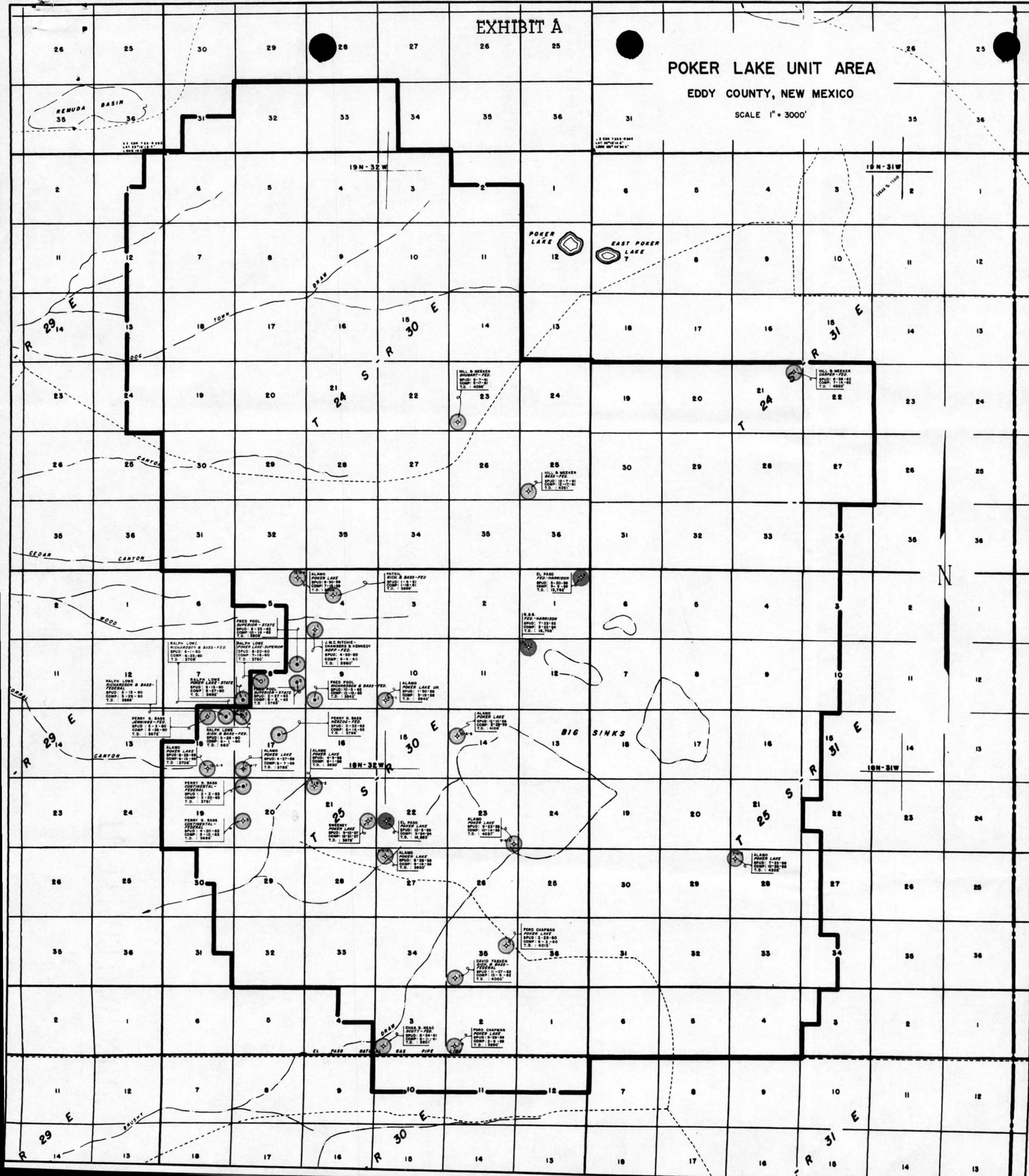
