CASE 13534: Application of OXY USA WTP Limited Partnership for Compulsory Pooling, Eddy County, New Mexico. Applicant seeks an order pooling all mineral interests in all formations from the surface to the base of the Morrow formation in the following described acreage in Section 15, Township 19 South, Range 27 East: the E/2 to form a standard 320-acre spacing and proration unit for all formations developed on 320-acre spacing within that vertical extent which includes but is not necessarily limited to the Angell Ranch Atoka-Morrow Gas Pool; and the NE/4 to form a standard spacing and proration unit for all formations developed on 160-acre spacing within that vertical extent. OXY proposes to dedicate the above-referenced spacing or proration units to its Fat Cactus Federal Well No. 1 to be drilled at a standard gas well location 660 feet from the North line and 1400 feet from the East line (Unit B) of said Section 15, to an approximate depth of 10,650 feet to test any and all formations from the surface to the base of the Morrow formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of OXY USA WTP Limited Partnership as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 12 miles southwest of Artesia, New Mexico.

<u>CASE 13535</u>: Application of Yates Petroleum Corporation for approval of a Unit Agreement, Lea County, New Mexico. Applicant seeks approval of the Ike State Exploratory Unit from the surface to the base of the Mississippian formation in an area comprising 3016.04 acres of State of New Mexico lands in Sections 25 and 36 in Township 12 South, Range 34 East, and Sections 29, 30, 31, and 32 in Township 12 South, Range 35 East, which is located approximately 10 miles west of Tatum, New Mexico.

<u>CASE 13536</u>: Application of Yates Petroleum Corporation for approval of a Unit Agreement, Lea County, New Mexico. Applicant seeks approval of the Wills State Exploratory Unit from the surface to the base of the Mississippian formation in an area comprising 9880.53 acres of State of New Mexico lands in Sections 11,14, 15, 16, 17, 19, 20, 21, 23, 26, 27, 28, 29, 30, 31, 34 and 35 and to depths below 9400 feet to the base of the Mississippian in Section 22 in Township 10 South, Range 33 East, which is located approximately 15 miles west of Crossroads, New Mexico.

<u>CASE 13537</u>: Application of Yates Petroleum Corporation for an Order (1) directing Pride Energy Company to reimburse Yates for the well costs incurred by Yates in its attempt to re-enter the State "X" Well No. 1 (API No. 30-025-01838) located in Section12, Township 12 South, Range 34 East, NMPM, prior to the time Pride Energy Company assumed operations of the well, (2) directing Pride Energy Company to account for and pay all sums it is now improperly holding pursuant to expired orders of the Division and Commission, and (3) requiring Pride Energy Company to plug and abandon the State "X" Well No. 1, Lea County, New Mexico. Applicant seeks (1) an order directing Pride Energy Company ("Pride") to reimburse Yates for the costs Yates incurred in its re-entry operations on the State "X" Well No. 1 (API No. 30-025-01838) located 1980 feet from the North line and 660 feet from the West line (Unit E) of Section 12, Township 12 South, Range 34 East, prior to the time Pride assumed operations of the well, (2) an order directing Pride to account to and refund to Yates all of the portion of the estimated share of well costs for the State "X" Well now improperly held by Pride pursuant to expired orders of the Division and Commission, and (3) an order directing Pride to plug and abandon the State "X" Well. Said well and spacing unit are located approximately 12 miles west northwest of Tatum, New Mexico.

<u>CASE 13538</u>: Application of Read & Stevens, Inc. for a Non-Standard Oil Proration Unit, Lea County, New Mexico. Applicant seeks to establish a non-standard oil spacing and proration unit for wildcat San Andres oil production to comprise 53.64 acres, more or less, by combining Lot 4 (consisting of 27.28 acres) and the easterly most 26.36 acres of the SE/4 SW/4 (Unit N) of Irregular Section 17, Township 19 South, Range 39 East, which is located on the Texas/New Mexico state line approximately four-and-a-half miles southeast of Hobbs, New Mexico. This unit to be dedicated to its proposed Brumley "17" Federal Com. Well No. 1 to be drilled at a standard oil well location 330 feet from the South line and 485 feet from the East line (Lot 4/Unit O) of Irregular Section 17.
