

4. **CASE 14937:** (Continued from the January 24, 2013 Examiner Hearing.) **Application of Cimarex Energy Co. for designation of a non-standard oil spacing and proration unit and for compulsory pooling, Lea County, New Mexico.** Applicant seeks an order consolidating the 40-acre spacing units within the E/2 W/2 of Section 25, Township 23 South, Range 32 East, NMPM and designating the consolidated units as a 160-acre± non-standard oil spacing and proration unit for a well location in the Bone Spring formation for Applicant's horizontal drilling project area. Applicant further seeks the compulsory pooling of all interests in the Bone Spring formation underlying the E/2 W/2 of Section 33 to be dedicated to its Triste Draw 25 Fed. Com. Well No. 3 to be drilled horizontally from a surface location 330' from the South line and 1980' from the West line (Unit N) to a bottom hole location 330' from the North line and 1980' from the West line (Unit C), to a depth sufficient to test the Bone Spring formation underlying the proposed project area in Section 25. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Cimarex Energy Co. as operator and a charge for risk involved in drilling the well. The proposed well and lands are located approximately 4 miles east of Bootleg Ridge, New Mexico.

Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the E/2 W/2 of Section 13 to form a non-standard 160 acre oil spacing and proration unit (project area), for all pools or formations developed on 40 acre spacing within that vertical extent. Applicant further seeks the pooling of all mineral interests in the Yeso formation underlying the non-standard oil spacing and proration unit (project area) for any formations and/or pools developed on 40 acre spacing within that vertical extent. The unit is to be dedicated to the BAE 14 Fed. Com. Well No. 1H, a horizontal well to be drilled at a surface location in the NE/4 NE/4, with a terminus in the NW/4 NW/4, of Section 14. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 2 miles southeast of Maljamar, New Mexico.
