

**APPLICATION**

Devon Energy Production Company, L.P. applies for an order amending the special rules and regulations for the Northwest Fenton-Delaware Pool (the "Pool"), and in support thereof, states:

1. Applicant is an operator in the Pool.
2. The Pool was created by Division Order No. R-7555, and currently includes the

following acreage:

Township 21 South, Range 27 East, N.M.P.M.

Section 1: W/2 and SE/4  
Section 2: S/2  
Section 11: All  
Section 12: All  
Section 13: W/2  
Section 14: NE/4

Township 21 South, Range 28 East, N.M.P.M.

Section 7: NW/4 and S/2  
Section 8: SW/4

3. Pursuant to Division Order No. R-13656-A, issued in Case No. 14936, the Pool has temporary special rules and regulations providing for a depth bracket allowable of 200 barrels of oil per day for a standard 40 acre oil spacing and proration unit.
4. Since the hearing held in Case No. 14936, applicant has obtained additional production data which indicates that the depth bracket allowable should be increased from the


rate approved in Order No. R-13656-A. As a result, applicant requests that the temporary special rules and regulations for the Pool be amended to provide for a special depth bracket allowable of 300 barrels of oil per day.

5. Applicant requests that the amended pool rules be made effective as of November 1, 2012.

6. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

**WHEREFORE**, applicant requests that, after notice and hearing, the Division grant the relief requested above.
