STATEMENT OF THE CASE

APPLICANT

George Ross Ranch, LLC ("Ross Ranch") seeks an order revoking Administrative Order No. SWD-380, which approved the administrative application of Mallon Oil Company to inject produced water into the Amoco Fed. Well No. 1, located in the NE¹/₄SE¹/₄ of Section 27, Township 26 South, Range 29 East, N.M.P.M.

OPPONENT

SWD-380 was issued in 1989. Notice of the administrative application was apparently not given to the surface owner (predecessor(s) to Ross Ranch). Cimarex assumed operation of the injection well a number of years after SWD-380 was issued.

Cimarex objects to the relief requested by applicant, for the following reasons:

1. The SWD application was technically correct and it was properly approved by the Division.

2. Cimarex is disposing only on-lease produced water into the injection well, which it is legally entitled to do.

3. If Ross Ranch has a claim against Cimarex (which Cimarex denies), District Court is the proper venue.
