Chi Operating, Inc. ("Chi") as Operator hereby proposes to drill the captioned well at the referenced surface location (SHL) to the referenced bottom hole location (BHL). The proposed well will be drilled to a true vertical depth of approximately 7,750' and shall be drilled to a true measured depth of approximately 13,000' in the Second Bone Spring Sand. The W/2W/2 of Section 25 will be the pooled oil proration unit.

Chi proposes to form a 320 acre, (W/2 of Section 25), Working Interest Unit (WIU) covering the Bone Spring formation. Should Cimarex desire not to join, Chi would be interested in acquiring a term assignment covering the Bone Spring formation with acceptable terms.

Enclosed is the proposed Operating Agreement dated April 1, 2012 along with an AFE for your execution, which covers rights from the top of the Bone Spring formation to the base of the Bone Spring formation and excludes currently existing wellbores, associated production and operation of same. Chi will operate the proposed WIU. A Drilling Title Opinion is being prepared at this time, and will be forthcoming. It would be appreciated if Cimarex could call and discuss this area as there are some issues concerning Cimarex's interest in the NE/4SW/4.
