### Gentlemen:

Chi Operating, Inc. ("Chi") as Operator hereby proposes to drill the captioned well at the referenced surface location (SHL) to the referenced bottom hole location (BHL). The proposed well will be drilled to a true vertical depth of approximately 8,720' and shall be drilled to a true measured depth of approximately 13,000' in the Second Bone Spring Sand. The W/2W/2 of Section 25 will be the pooled oil proration unit.

Chi had proposed to form a 320 acre, (W/2 of Section 25), Working Interest Unit (WIU) covering the Bone Spring formation, however this Working Interest Unit proposal has been rescinded. Due to the area location, the well has been moved to the captioned location. Should Cimarex desire not to join in the drilling of the Peacekeeper "25" State Com No. 3H, Chi would be interested in acquiring a term assignment covering the Bone Spring formation with acceptable terms.




