1 EXAMINER WARNELL: Let's call Case Number  
2 14637, application of OGX Resources, LLC, for approval of  
3 a nonstandard oil spacing and proration unit and  
4 compulsory pooling, Eddy County, New Mexico. Call for  
5 appearances.

6 MR. BRUCE: Mr. Examiner, Jim Bruce of  
7 Santa Fe, representing the applicant. I have no  
8 witnesses.

9 EXAMINER WARNELL: This case was heard by  
10 Mr. Brooks?

11 MR. BROOKS: That's right.

12 MR. BRUCE: Do you have your land plat in  
13 there, Mr. Brooks?

14 MR. BROOKS: I suspect I do.

15 MR. BRUCE: Mr. Examiner, this case was  
16 presented to you four weeks ago. This well was  
17 originally proposed as a horizontal, covering five  
18 quarter/quarter sections or lots. At one point, they  
19 changed that to include an additional quarter/quarter  
20 section.

21 So it would have included six quarter/quarter  
22 sections within the east half/east half of Section 30 and  
23 the east half/northeast quarter of short Section 31 in 26  
24 South, 29 East. And that is the way I originally filed  
25 the application.

1 But then they reverted just to five  
2 quarter/quarter sections, so I amended the application to  
3 reflect that it only covers the southeast/northeast, the  
4 east half southeast of Section 31 and Lot 7 in the  
5 northeast quarter/northeast quarter of 31, and I gave  
6 notice to everyone again.

7 Exhibit X is the affidavit of notice to the  
8 offsets. And there is evidence in the record from the  
9 testimony of the landman that the only two offsets, other  
10 than OGX itself, were OXY USA and the Bureau of Land  
11 Management as to unleased federal land. And so they were  
12 given notice of the amended well nonstandard unit.

13 And Exhibit Y is the notice to Chesapeake  
14 Exploration, which is the only party being pooled. All  
15 parties received actual notice. So I would move the  
16 admission of Exhibits X and Y and ask that the matter be  
17 taken under advisement.

18 MR. BROOKS: Exhibit A to what's marked as  
19 Exhibit 10 from the original hearing, then, is the  
20 correct plat?

21 MR. BRUCE: It is the correct plat, yes.

22 MR. BROOKS: Exhibits X and Y will be  
23 admitted, and Case Number 14637 will be taken under  
24 advisement.


