



Robert E. Scott died in January 1986 in Roswell, NM. (could not locate probate/obituary)

His wife, Rozella died in March 1994 in Roswell, NM

The Fort Scott Tribune (Fort Scott, KS) listed a death notice for Rozella (Moody) Scott, wife of Robert E. Scott, naming Joe Scott as her only child, who was still living at her time of death. Her only surviving sister lived in Fort Scott and her only surviving brother lived in Tulsa, OK.

Searching for Joe Scott returned tons of results, as you can imagine. The most promising I found was a Joseph Scott/Joseph N. Scott, married to Joyce Scott listed as having lived in the following places: Albuquerque, NM, Rio Ranch, NM, Roswell, NM and Hamden, CT.

She was a homemaker. She was married to Olaf Coleman, who preceded her in death. She is survived by her daughter, Deanna C. Martin, and husband, Robert Blanc of Clinton, and four grandchildren.

I also found a book, "The Daisy Chain" that references a Dr. Olaf Coleman as being a new surgeon in the midst of the Great Depression. The book also references his wife as being named "Dolores", so I am confident that the two Dr. Coleman's are the same person, but unsure that it is the Dr. Coleman we are looking for.


