

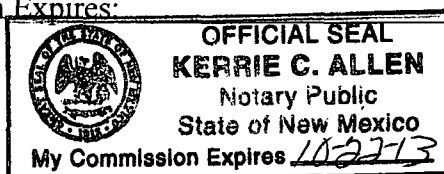


Ladies and gentlemen:
