- 1. <u>CASE 14988</u>: Application of Amtex Energy, Inc. for approval of a Unit Agreement, Lea County, New Mexico. Applicant seeks approval of the Merchants State Unit comprised of 1280.12 acres of State of New Mexico lands in Section 35 in Township 21 South, Range 33 East, NMPM, Lea County, and Section 2 in Township 22 South, Range 33 East, NMPM, Lea County. The unitized area includes from the top of the Bone Spring formation to the top of the Strawn formation. This area is located approximately 21 miles west of Eunice, New Mexico.
- 2. <u>CASE 14989</u>: Application of Apache Corporation for compulsory pooling, Lea County, New Mexico.
