If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued. A party who plans on using projection equipment at a hearing must contact Florene Davidson seven (7) business days prior to the hearing requesting the use of the projection equipment. 1. ***CASE 15011: Amended Application of ConocoPhillips to terminate the Trail Canyon Gallup Gas Pool and expand the Basin-Mancos Gas Pool, San Juan County, New Mexico.*** Applicant, in the above-styled cause, seeks to terminate Trail Canyon Gallup Gas Pool and correspondingly expand the Basin-Mancos Gas Pool so that production can be downhole commingling with/or Dakota, Mesaverde, and Basin-Mancos gas production in the wellbores of existing or future wells drilled anywhere within the area formerly subject to the Trail Canyon Gallup Gas Pool located in parts of Sections 16, 17 and 18 of Township 32 North, Range 8 West, NMPM, San Juan County, New Mexico. The center of said area is located approximately 12 miles northeast from Cedar Hill, New Mexico.
2. ***CASE 15012: Application of Burlington Resources Oil & Gas Company, LP, for the establishment of a downhole commingling reference case, including the deletion of notice requirement, for its San Juan 27-4 Unit pursuant to Division Rule 19.15.12.11.D, Rio Arriba County, New Mexico.*** Applicant, in the above-styled cause, in accordance with Division Rule 19.15.12.11.D seeks to establish a downhole commingling reference case to provide for (a) marginal economic criteria, (b) cross flow criteria (c) pressure criteria, (d) fluid compatibility and water sensitivity/damage issues (e) value issues (f) allocation formulas, and modification of notification rules on an area-wide basis authorization for downhole commingling from the BS Mesa-Gallup Pool so that production can be downhole commingling with/or Dakota, Mesaverde, and Basin-Mancos gas production in the wellbores of existing or future wells drilled anywhere within the San Juan 27-4 Unit located in Township 27 North, Range 4 West, NMPM, Rio Arriba County, New Mexico. The center of said area is located approximately 5 miles northeast from Cebolla, New Mexico.
