Application of COG Operating LLC for a non-standard spacing and proration unit and compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order (1) creating a non-standard, 160-acre spacing and proration unit comprised of the S/2 S/2 of Section 1, Township 17 South, Range 29 East, NMPM, Eddy County, and (2) pooling all mineral interests in the Yeso formation underlying this acreage.
