So noted. I will make sure that you are alerted when an IPI application has been submitted on a Federal well and placed in the schedule on RBDMS. I will try to be as proactive as Will in keeping you informed of SWD/AGI/IPI applications. It seems that there is a severe disconnect in notification of SLO and BLM by applicants for these applications.

Also, tomorrow's docket includes Case 14979 –Mesquite SWD application for the proposed Paduca Federal SWD #3 (Unit C/Sec.23/T25S/R32E). You had already submitted a written protest in January. Yates et. al. has filed a pre-hearing summary and will be protesting based on their exploratory program in the area. I'll keep you informed on this project.
