The intended surface hole location for the well is 330' FNL & 2010' FEL and the intended bottom hole location is 330 FSL & 1980' FEL. The well is proposed to be drilled vertically to a depth of approximately 10,953' to the Bone Spring formation and laterally in a westerly direction within the formation to the referenced bottom hole location. Total measured depth of the well is proposed to be approximately 15,700' from surface to terminus.




