



Andrew, force pooling is when there are some uncommitted leasehold or mineral owners either locatable or unlocatable owners who have elected not to participate in proposed wells. We have what is called a Compulsory Pooling Hearing at the New Mexico Oil Conservation offices in Santa Fe at an Examiner's Hearing whereby we testify at the hearing and present evidence of our efforts to find these owners and the results thereof of whether or not such owners have agreed to participate in the proposed well. If those owners don't participate in the proposed well, we carry their working interest for the cost of drilling and completing the well until we have recovered the well cost plus 200% from production. This is a non-consent penalty which allows us and the participating owners to timely drill the well. After 300% is recovered from production, those pooled parties become joint interest owners in the well and receive revenue attributable to their leasehold or unleased mineral interest and those owners from then on pay their proportionate part of future well and operating costs. Until 300% payout, those owners pay and risk nothing. As I advised you earlier, this Compulsory Pooling Hearing or "force pool" hearing will occur in Santa Fe, NM on Oct 17th. You are not required to attend this hearing but you are afforded the opportunity to attend same. You will be sent notice of this hearing by our attorney.
