Gentlemen:

Devon Energy Production Company, L.P., ("Devon") as operator, proposes to drill the referenced wells as horizontal Lower Brush Canyon Delaware wells, expected to require drilling to an approximate total vertical depth of 6,400' and approximate total measured depth of 14,000'. Each of the proposed wells will be drilled back to back from a common drill pad. Enclosed you will find Devon's AFE, in duplicate, for each of the proposed wells reflecting our estimated cost for each of the wells to be approximately \$6,150,000.00.

Title review reflects that multiple Joint Operating Agreements have historically been executed by some but not all of the current interest owners or their predecessors and in some instances covering some but not all of the lands covered by the proposed project areas. In that regard, Devon also submits for you review, approval and execution a new Joint Operating Agreement superseding all prior Joint Operating Agreements covering both of the referenced project areas and creating a working interest unit covering same.


